### ALL SAGINAW-TUSCOLA MCA PROVIDERS:

We will be recertifying the regional medication boxes and kits on Friday October 27, 2017. Everyone please have your boxes and kits to your area pharmacy beginning at 07:00.

With this recertification, there will be some significant changes:

- 1. Longer (5.25") **14 GA. catheters** will replace the current 14 GA. This is to better facilitate pleural decompression when necessary. Two catheters instead of three will be stocked due to the higher cost.
- 2. **Diazepam** remains unavailable to all of our hospitals. The current supply is what we have moving forward with no sign of availability in the near future. Consequently, we will be reducing the number of diazepam vials from two to one. The vials pulled during recert will serve as stock for the future but for now, when we run out, that will be it. Watch the top of the box for a warning label if diazepam becomes unavailable or has been short-dated in the box.
- 3. As you know, **naloxone** usage is on the rise. To help, we are moving two of the naloxone and one of the atomizers to the IV/ALS Kit. You will now have equal amounts of naloxone/atomizers in both the kit and the box.

## 4. Duo-Dote

- The Region 3 Healthcare Coalition has a stockpile of Duo-Dote autoinjectors for use in organophosphate or nerve agent exposure/poisoning. These were previously stored and not readily available to those who would need them.
- Two Duo-Dote auto-injectors will be added to the bottom of the box.
- Each Duo-Dote contains 2.1 mg of atropine and 600 mg pralidoxime chloride. Refer to the CBRNE Nerve Agent/Organophosphate Pesticide protocol for further.
- Since this is an auto-injector, remember to hold the syringe firmly at the injection site for at least 10 seconds.
